**Vineyard 7 & 8:** After a careful and patient search, the Steffens family concluded their quest with the purchase of a forty-acre vineyard estate atop Spring Mountain.

Planted in the early 1980s with eight acres each of Cabernet Sauvignon and Chardonnay, the property met the family's stringent requirements, enabling them to craft wines with a true sense of place.

'Vineyard 7 & 8', named after proprietor Launny Steffens's life in finance, reflecting a theme of numerics & a keen interest in numerology. The number 7 symbolizes luck in Western culture, while 8 signifies prosperity and happiness in Eastern culture.

Vineyard 7 & 8 embodies the family's pursuit of producing fine wines, including Cabernet Sauvignon and Chardonnay, showcasing the unique terroir of their estate.


